According to the International Sporting Code Art. 3.8.1 an entry compels the competitor to take part in the Competition in which they have been accepted to run, except in case of duly established Force Majeure.

Art. 4.2.1 Entry Eligibility

The National event is open to Motorsport UK and Motorsport Ireland International / National licence holders competing in cars which are eligible to compete.

The Interclub event is open to all fully elected members of Wolverhampton & South Staffordshire Car Club Ltd, registered contenders in the championships listed in Art 2.1, and members of clubs affiliated to:

- Welsh Association of Motor Clubs
- Association of West Midlands Motor Clubs
- Association of North Western Car Clubs

Interclub event drivers must hold an RS Interclub - Stage Rally (UK only) licence or higher, or Motorsport Ireland equivalent. Interclub event Co-drivers must hold an Interclub status licence or higher, or Motorsport Ireland equivalent.

Where applicable an entrant's licence must also be held.

All Competitors will be given Free membership to WSSCC if membership is required

Both events have also been inscribed on the National Competitions with Authorised Foreign Participation (NCAFP) Calendar 2024. Licence holders from other FIA recognised ASN's will be allowed to compete if they have approval from their own ASN.

Art. 4.3 Number of competitors accepted and vehicle classes

Art. 4.3.1 The number of competitors shall be limited to 160. The minimum is 90.

The minimum for each class for Awards is 5.

Should any of the above figures not be reached, the organisers reserve the right to amalgamate classes or cancel the event.

Vehicles that comply and run under 2024 Motorsport UK vehicle regulations for Historic Rally Cars (Motorsport UK Yearbook 2024, Section R.49 and Section K) must be in possession of a Historic Rally Vehicle Identity Form (HRVIF). Vehicles that comply and run under the current FIA Appendix K Regulations must be in possession of a valid FIA Historic Technical Passport. Category 3 and 4 cars must also present

the appropriate homologation form, or any other documentation listed in 2024 Motorsport UK Yearbook. Road rally class will be permitted to allow cars to run under Motorsport UK stage rally rules for tyres and graphics. In case of the need for auxiliary lighting then GR R.48.8 applies.

Vehicles with forced induction (except diesel engined) and rotary engines will have their capacity increased by 70% to establish their class, all in accordance with GR J.5.4.1.

This insurance cover will come into effect from the start of the event and will cease at the end of the rally or at the moment of retirement, disqualification or exclusion.

Art. 5.1.2. Entrants and Driver Requirements

Vehicles must have a valid motor insurance policy which provides as a minimum Third Party Liability cover that complies with the Road Traffic Act. This can be either, by extending an existing motor policy to cover the event, or, by purchasing additional cover, providing under the Event Road Section Scheme as an adjunct to an existing motor policy. If a competitor has an extension to their existing policy, they will be required to sign a declaration that the cover complies with the requirements of the Road Traffic Act. Any responsibility for a fraudulent or misleading declaration about existing cover lies with the competitor.

If a competitor wishes to purchase additional Road Section cover via the organisers, then they can do so prior to the event providing they comply with the following:

- has held a full UK / EU driving licence for a minimum of 6 months OK.
- has no more than 6 conviction points on their licence and no bans of any kind OK

- do not have the Third-Party Extension cover on their existing motor policy.
- the vehicle has a valid MOT and taxes for the road, unless exempt from doing so

Anyone aged less than 19 years old will also be accepted at the same price should their co-driver be a more senior member of their family or over 25. Any competitor who falls outside these parameters may be offered cover at equivalent terms or an agreed price, if approval from the Appointed Insurance Broker has been obtained by the event organisers, prior to the event. Approval can be sought by Event Organisers sending an email to the contact@reis.co.uk and provide the Drivers' name and date of birth, the date they passed their driving test and full details of any motoring claims and/or convictions.

Additional cover provided by this scheme is only effective whilst the vehicle is actively competing in the event and remains under the control or direction of the event organiser(s). Cover will cease immediately if you are precluded, excluded or retire from the event.

Art. 6. Advertising and Identification

See Appendix 4 of these SR "Decals and positioning of supplementary advertising".

Art. 6.1 Obligatory organiser's advertising

Advertising and identification provided by the organisers is as follows:

- Rally Plate Front (300mm x 210mm)
- Rally Plate Rear Window (180mm x 180mm)
- Door Header Plates (670mm x 170mm)
- High Visibility Competition Numbers on both Rear Side Windows (250mm high)

Each crew must provide their own Competition Door Plates for Driver and Co-Driver Doors (500mm x 500mm), to be in accordance with GR J.4.

All plates are mandatory. Alteration to any advertising and identification provided by the organisers is forbidden. Any competitor who's advertising and identification is altered in some way will be excluded from the event.

All Obligatory Organiser's Advertising must be affixed to each competing car before it is presented for scrutineering.

Please refer to Appendix 4 "Decals and Positioning of Obligatory Advertising"

Competitors registered in the various championships are reminded of their requirement to display the appropriate championship decals.

Art. 7. Tyres

Art. 7.1 Regulations regarding tyres which may be used during the rally.

See GR L.3. and R.48.5. (Wheels and Tyres), and additionally GR R.49.10. for cars in the B1-G2 and W5-W9.

Hand cutting of tyres is not allowed.

Art. 7.2 National laws or special requirements

In accordance with GR R.48.5.11, the approved maximum quantity of tyres per competing car for the event will be **10 tyres**.

In the event of an extreme weather event (defined as: Temperatures over 28°C for a 24-hour period), the Clerk of the Course may request the Motorsport UK Steward to suspend the tyre allowance on the grounds of safety.

Art. 8. Fuel

All types of fuel must follow FIA Appendix J Art. 252.9. and GR J.5.15.4.

Art. 8.1 Fuel Ordering procedure

The recommended fuel supplier for the event is **Vital Equipment Ltd**. Fuel can be ordered via their website www.vitalequipment.co.uk or by calling them on 01981 241169. The onus is on the competitor to order their fuel before the rally – the event organisers will not be involved in this process in any way.

Art. 8.2 Closin g date for ordering fuel

Fuel order closing date is 17.00 GMT on 8 March 2024

Art. 9. Reconnaissance of Special Stages

Unauthorised pre-event reconnaissance, practicing or testing over the Special Stages used on this event is **FORBIDDEN**.

Any Competitor or their agent observed on National Resources Wales land without the relevant permission, within the area covered by the maps specified (being OS Landranger 124, 125, 126) in these Supplementary Regulations after their publication, will be refused a start or disqualified from the results as appropriate. The only exception to this regulation will be for people who live on or whose employment causes them to travel along part of the route used on the event.

- Car registration papers (to be presented at scrutineering)

Art. 10.2 Timetable

Art. 11. Scrutineering, Sealing and Marking

Art. 11.1 Scrutineering, venue and time

Cars may be presented at scrutineering by a representative of the team. See programme (SR Art. 3)

Art. 11.1.1 Scrutineering, mandatory documents

- Motorsport UK / Motorsport Ireland Vehicle Passport / Competition Car Logbook
- Cars complete certified homologation (where applicable)
- Historic Rally Vehicle Identification Form / FIA Historic Technical Passport (where applicable)
- Car Registration Documentation
- SOS / OK board (A4 format)
- Small spill kit, in accordance with GR K.3.

The installation of the safety tracking system will be checked at scrutineering.

Competitors wishing to carry an in-car camera may do so in accordance with GR J.5.21, and the installation will be checked at scrutineering. Any competitor using an in-car camera must supply the organisers with a copy of the footage on request. The commercial rights to all video and sound material recorded during this event remain the property of the organisers.

Art. 11.1.2 Timetable for scrutineering

See programme (SR Art. 3)

Limited scrutineering may be available on Saturday morning, only upon arrangement / appointment as agreed with the Event Secretary Sarah Jones - dyfnant2@gmail.com

Art. 11.2 Mud flaps

It is mandatory to fit transverse mud flaps in conformity with GR R.48.1.2.

Art. 11.3 Windows

Use of tinted windows is not authorised in accordance with Article 253.11 "Windows/nets" of Appendix J of the FIA International Sporting Code and GR R.48.1.10.

Art. 11.4 Drivers' safety equipment

All items of clothing including helmets and FHR (Front Head Restraint) intended to be used, e.g. HANS devices, must be presented for scrutineering. They shall be checked for compliance with Motorsport UK Yearbook Section K.

Art. 11.5 Noise level

The organisers will conduct static sound tests prior to the start.

For all cars, noise tests will be conducted in accordance with GR R.4.1 and J.5.18. All competitor vehicles must pass these tests, which will allow for a maximum of 100 dBA at 4500 rpm, using the 0.5 metre test.

Art. 11.6 Special national requirements

For all classes, the Technical Regulations of the 2024 Motorsport UK Yearbook shall apply.

Art. 11.7 Installation of the safety tracking system

In association with RBI Sport Geotraq, the rally will operate a mandatory GPRS/GSM safety tracking system that will enable the speed and position of each competing vehicle to be monitored and logged. Before the start, all cars will be fitted with a tracking device prior to scrutineering. The tracker will remain active throughout the event. This must be retained in the car until the finish of the event, when it will be removed by the system providers. Further information will be available in the final instructions.

Should you retire from the event, please return your tracking device to Rally HQ. Failure to return the tracker or returning the tracker in a damaged state will result in financial penalties outlined in the document "DAMAGE / NON-RETURN CHARGES FOR GPS/SATELLITE TRACKING EQUIPMENT" on the Digital

Notice Board. If the tracking device is not returned or payment has not been made to the supplier for loss or damage, the crew will be reported to Motorsport UK under Article C.1.1.13 and your competition licences will be suspended until payment is made or the undamaged tracking device is returned.

Art. 12. Other procedures and regulations

Art. 12.1 All competitors will start from MC0 at Welshpool Livestock Sales.

Art. 12.1.2 Start Order

The start order will be 2-wheel drive cars in reverse order of anticipated performance, followed by a short gap of 5 to 10 minutes, followed by 4-wheel drive cars in order of anticipated performance.

The order of starting will be at the organisers' discretion, in accordance with GR R.24.1.4. The organisers reserve the right to re-seed any change of car, driver and/or class.

Art. 12.2. Rejoining

Competitors who retire from the four stages may rejoin the event at MC3 Service Out, following rescrutineering. Competitors who rejoin will be seeded within but not ahead of 15 places of their original seeded position, in accordance with GR R.40.1.7.

To be classified as a finisher, competitors must complete two thirds of the stages [i.e. 6 out of 8] and report to the final time control [MC 4] within the maximum lateness specified, with the car in which they started.

Art. 12.3 Permitted early check-in.

Early check-in in accordance with the provisions of GR R.30.3.3 is permitted at the final control of the rally, MC4. Competitors arriving early must have their due time entered on the Timecard; those arriving later than their due time must have their actual time of arrival entered.

Art. 12.3.1 Permitted lateness

The total Maximum Permitted Lateness (penalty free) will be 15 minutes between Main Time Controls.

Competitors must leave MTCs on their due time or be penalised in accordance with GR R.32.1 – R.32.2.

Art. 12.4 Start procedure on Special Stages

The electronic start procedure is as follows:

30 Seconds: RED light will be displayed.

15 Seconds: RED and AMBER lights will be displayed.

10 Seconds: RED light will go out.

5 Seconds: AMBER Countdown 5-4-3-2-1

START TIME: GREEN light goes ON. 5 Seconds after start time: GREEN light goes out.

The system is electronically coupled to a start line detection device that records any situation where the car leaves the start line ahead of the correct signal.

In the event of failure of the electronic system, the timekeeper will count down aloud: 30 seconds; 15 seconds; 10 seconds and the last 5 seconds one by one, and then raise a flag or hand for the competitor to start the stage.

Any car not starting from the start line within 20 seconds after the start signal will be considered as retired and immediately moved to a safe place.

Art. 12.5 Refueling

Art. 12.5.1 Refueling is only allowed in Refueling Zone (RZ) and commercial fuel stations. To refuel in the service park is forbidden at any time.

Art. 12.5.2 To access a Refueling Zone, all personnel involved in refueling operations must wear clothing that provides adequate protection against fire and includes at least: long trousers, long-sleeved top and closed shoes.

Art. 12.5.3 Environmental Mat in a Refueling Zone (RZ)

The organiser will protect the ground with an Environmental Mat.

Art. 12.6 Finish procedures and other activities after the finish of the rally

Art. 12.6.1 There will be a specific finish procedure. A finished ceremony will be held at the Final Time Control in Welshpool Town Centre. All finishing crews and cars will be arranged in the finish area, prior to crossing the finish ramp, and the Top 3 Overall Crews in the Event, the Top 3 British Historic Rally Championship Finishers, the Top 3 Welsh Rally Championship Finishers, and others as may be outlined by the event organisers, will be required to attend the Finish Podium Ceremony.

Art. 12.6.2 Availability of participants

In accordance with GR H.32.1.6., participants upon passing the finish line, must remain available by phone (mobile) until the final classification has been posted.

Art. 12.6.3 Classification

The final classification will not be distributed after the event. The final classification will be published on the Digital Notice Board https://webapp.sportity.com/channel/wsscc24

Art. 12.7 Official time used during the rally.

Official time will be GMT / Greenwich Meant Time. All clocks will be set to BBC / British Telecom time.

Rally time can be checked at www.time.is

Art. 12.8 Rally Emergency Telephone Number

The emergency number for the rally is +44 (0)7864 666568.

It is mandatory for all crews to save this number in their mobile phones, to ensure quick dialing in emergency cases.

Art. 12.9 Special Procedures for the Service Park

Art. 12.9.1 Service Pass and Service Space

All competitors will be issued with a service pass. The entry fee permits a rally car and one service vehicle into the Service Park at Welshpool Livestock Sales, where a 7m x 7m pitch will be provided.

Art. 12.9.2 Service Area Speed Limit

The maximum speed in the whole service area is **10 MPH / 16 KPH**. Competitors or their representatives found to be exceeding service area speed limits will be referred to the Clerk of the Course.

Art. 12.9.3 Behaviour in the Service Park

Only competition cars and service vehicles with attached event-specific service plates are allowed to enter the Service Park.

The surface of the service area shall not be damaged. Nails, screws, or similar materials for fixing onto the surface of the service area are not allowed. The competitor is liable for damages in the service area assigned to their team.

The following rules apply:

- In the Service Park a liquid-tight ground sheet with a minimum size of 6 x 3 metres must be placed under the competition car as long as service works are being carried out.
- Service works shall not cause sustainable, avoidable or ecological damage.
- Refueling is only allowed in the designated Refuel Zone or petrol stations.
- At any time, the team must have a sufficient volume of oil absorbent materials and canisters for the disposal of waste oil, brake fluids, etc.
- Waste, packing materials, vehicle parts, tyres, empty oil cans, batteries, etc., must be taken away and disposed of by the team.
- Any materials or liquids on the ground sheets / environmental sheets must be placed in the competitors' own containers and removed from the service park.
- Teams and competitors are required to have a sufficient supply of disposal bags to remove their rubbish. This requirement will be checked by Judges of Fact.

After the end of the event, it is very important for future use of the venue by the event, that individual service bays must be handed over in a clean and tidy condition.

Art. 12.9.4 Infringement of Service Park Regulations

Infringement of these regulations will be reported to the Clerk of the Course for penalties, and the cost of the disposal company and associated damage repairs will be charged to the team / competitor.

Art. 12.9.5 Security

The service area is only guarded temporarily. The organisers take no responsibility for the belongings of teams / competitors.

Art. 12.9.6 Electricity in the Service Park

There will be no electricity available to teams / competitors.

Art. 12.9.7 Trade Vehicles

Trade vehicles such as tyre vans, merchandise sales, etc, operating within the Service Park will be subject to a market traders fee of £50, payable to the organisers.

Art. 12.10 Damage Declaration Form

Upon completion of the event at the final time control, or upon retirement, competitors will be required to complete and sign their damage declaration form at the rear of the timecards, in accordance with GR

R.40.1.3. This form refers to any third party damage the competitor may have contributed to during all sections of the rally.

Information given will not incur a penalty, but failure to disclose details of any such incident, or failure to hand in a duly completed form will be penalised in accordance with GR R.32.2. Competitors who do not report to the finish of the event or hand the form in to an official, are required to forward the report to the <u>organiser's representative</u> / Secretary of the Meeting within 72 hours of the finish of the event [GR R.40.1.4.]

Competitors who fail to comply may receive a fine of up to £100.

Competitors involved in an accident MUST give details to the organisers the same day.

Art. 12.11 Timecards

Timecards will be issued at MC0.

Additional Awards may be made at the discretion of the organisers.

Art. 15. Final Checks / Protests / Appeals

Art. 15.1 Final Checks

Time and location: see programme (SR. Art. 3)

Any teams required to undergo final scrutineering must immediately follow the instruction of the marshals in charge, even if this prevents them from proceeding to one or more time controls (TC). The complete original Vehicle Passport (VP) / Competition Car Log Book (CCLB), FIA homologation form (where applicable), Historic Rally Vehicle Identification Form (HRVIF) / Historic Technical Passport (HTP) (where applicable), and other necessary certifications must be available for final scrutineering. A representative of the competitor as well as mechanics with the appropriate tools (in case of dismantling) must be present at the final scrutineering.

Art.15.2 Protest deposit

The protest deposit is: GBP £300.00 (National) / GBP £155.00 (Interclub)

If a protest requires the dismantling and re-assembly of a clearly defined part of the car, any additional deposit will be specified by the Stewards upon a proposal of the Chief Scrutineer.

Art. 15.3 Appeal deposit

The deposit for an appeal to the stewards is: GBP £575.00 (National) / GBP £300 (Interclub)

The deposit for an appeal to Motorsport UK is:

All protests and/or appeals must be lodged in accordance with GR C.5. and C.6.

Art. 15.4 Fines



Appendix 4 – Extracts from Motorsport UK Yearbook relating to overalls, helmets and any other safety requirements.

GR R.5.3. In conjunction with scrutiny of the car, Drivers' and Co-Drivers' crash helmets, FHR Devices, and overalls must be produced for approval.

GR R.25.3.1. All crew members must wear a crash helmet bearing a Motorsport UK approval sticker (K.10.1 to K.10.3.1) and a safety belt throughout any Special Stage.

GR R.25.3.2. The crew must also wear flame resistant overalls homologated to FIA 8856-2000, FIA 8856-2018 or FIA 1986 Standard, and balaclavas to FIA 8856-2000 or FIA 8856-2018 Standard. Competitors are also strongly advised to wear Flame Resistant gloves, socks, and underwear. Plastic shoes (such as trainers) should be avoided. Attention is drawn to (K.9.1.5 to K.9.3).

GR R.25.3.3. The crew must also wear FIA approved FHR Devices, fitted in accordance with K.10.4.




Appendix 5 - Safety Tracking
